- 2024 Budget

 - Budget process
 - WPL's budget is primarily made up of state subsidy; RAD allocation; and local support from the Borough.
 - After Paula receives notice of what WPL will receive from the state and from RAD, she reconciles WPL's expenses with those numbers and uses that information to draft a proposed budget to be presented to Borough Council
 - o Generally, there will be an increase in expenses during the coming year based on staff needs and increases to coast of living and cost of supplies, etc.
 - Finance Committee will meet sometime in October before the Board meeting; thereafter, the budget will be presented to the Board at its regularly scheduled October meeting; once approved by the Board the budget will be presented to Council in November
